#### FEE INFORMATION DETAILS

Sunny Faces is a 12-month child care operation. Space is **not** held for any missed days or withdrawal purposes during the year. As a not-for-profit centre, Sunny Faces relies solely on parent fees and available government funding to remain a financially feasible child care centre.

Fees are processed via direct debit from your account on the 1<sup>st</sup> day of each month. Fee withdrawals may be delayed 24-48 hours for banking and or administrative interruptions.

**A last month base fee (20 business days)** will be debited from your account on the first month’s payment. This fee will be credited towards your last months fee. **A minimum of one month (20 business days) written notice is required for any withdrawal from the program.**

All non base fees will be charged an NSF fee of \$45.00. A late fee is levied at the rate of \$20.00 for every 15 minutes, per child, starting at one minute past the program time. Please refer to the Parent Handbook for more details.

## **CANADA WIDE EARLY LEARNING AND CHILD CARE (CWELCC) program**

**Sunny Faces** is a continued participant in the government funded CWELCC program that allows our child care centre to offer qualifying families a partial fee reduction for monthly fees.

Funding under the CWELCC system is intended to support children under the age of 6 (0-5 years), with some exceptions for children with birthdays early in the year who are 6 years of age but are still enrolled in kindergarten. Eligible children who receive reduced fees are defined under O.Reg.137/15:

- Any child, until the last day of the month in which the child turns 6 years old (irrespective of the type of licensed child care program in which they are enrolled): and
- Up until June 30<sup>th</sup> in a calendar year, any child who turns six years old between January 1 and June 30 in that calendar year: and
- Is enrolled in a licensed infant, toddler, preschool, or kindergarten group, a licensed family age group, or home child care

Please be advised that **Sunny Faces** fees have been adjusted for *qualifying families* with children five years of age or younger in accordance with the Canada Wide Early Learning and Child Care (CWELCC) program.

Subsidized families will continue to be charged their daily rate provided by the City of Toronto Children's Services.
